

For and in consideration of One Hundred Fifty Dollars (\$150.00) and other good and valuable considerations, paid to the Austria-Hungary Yad Charucim Congregation, also known as the Yad Charutzim Congregation of Cincinnati, Ohio, a religious society, created and existing under the laws of the State of Ohio, hereinafter designated "Party of the first part", paid by the Congregation Sons of Abraham of Norwood, Ohio, hereinafter designated "Party of the second part", the receipt of which is hereby acknowledged, the parties hereby agree and contract each with the other as follows:

Whereas, the parties entered into an agreement on the twenty-third of November, 1938, said agreement being duly executed by the parties, and whereas certain conditions have arisen necessitating changes and modifications in said agreement, the parties hereinto contract and agree that the herein supplemental agreement shall operate as a change and modification of said prior agreement in the following particulars only and that the said prior agreement is in full force and effect except for the following exceptions.

FIRST, The Party of the first part hereby agrees and contracts with the Party of the second part and hereby gives consent to the sale and transfer to the Congregation Tikwoh Chadaschah (New Hope), of that part of said Party of the second parts' parcel, which is more fully described as follows:

Situate in the County of Hamilton, State of Ohio, in Section 13, Town 2, Fractional Range 2, Green Township, Miami Purchase, being part of Lot 1, Abigail Wilson's Subdivision, as per Plat recorded in Plat Book 8, Vol. 11, Page 14, Hamilton County, Ohio, Recorder's Office, and more particularly described as follows:

Beginning at a point located 105 feet East of the West line of said Lot 1 of Abigail Wilson's Subdivision aforesaid (as measured parallel to the center line of Sidney Road, formerly Muddy Creek Pike.), and 316.50 feet North of the center line of said Sidney Road (as measured parallel to the West line of said Lot 1); thence Northwardly, parallel to said West line of said Lot 1, 197.89 feet to a point in the North line of the tract described in the Deed to Congregation Sons of Abraham, recorded in Deed Book 1812, Page 558, Hamilton County, Ohio, Records; thence North 48 Degrees 38 Minutes East, along said North line in Deed Book 1812, Page 558, 43.60 feet; thence Southwardly, parallel to the West line of said Lot 1, 228.78 feet; thence Westwardly, parallel to the center line of Sidney Road, 31 feet to the place of beginning.

Being part of the premises conveyed to Congregation Sons of Abraham by Deed from Austria-Hungary Yad Charucim Congregation, dated January 31, 1939, and recorded in Deed Book 1812, Page 558, Hamilton County, Ohio, Records. Also certain easements all as more fully described
